- 2 This approval does not include attachment to the lifejacket, it is the responsibility of the lifejacket manufacturer to ensure that the light is attached securely and in the correct position.



- 3 Detailed fitting, maintenance and in service test instructions are to be provided to each purchaser of the M4-A and W4-A lights.
- 4 Each light is to be marked with the information required by the LSA Code Regulation 1.2.2.9 and 1.2.3.
- The product conforms to performance standards not inferior to those adopted by the International Maritime Organisation (IMO) within LSA Code IMO Resolution MSC.48(66) and its latest applicable amendments.

Conditions of Validity

This issue of the Annex to the referenced Marine Equipment Module B Certificate relates to Issue 1 of the Certificate.

This certificate will not be valid if the manufacturer makes any changes or modifications to the approved equipment, which have not been notified to, and agreed with TÜV SÜD BABT, or a person appointed by TÜV SÜD BABT to perform that role.
